Additional member in the same household may join for \$2 annually, but only one copy of the official organ and the bundle will be sent to this household

# President's Message

As soon as I was elected president, serious issues came up for discussion at the Nashville convention. The issue that you should have already seen in the July bundle is the new change to membership dues.

I recall a joke from the previous convention that we ought to figure out how we were surviving as an organization, consistently coming close to breaking even when we would always budget a large deficit. The joke was that we needed to pass our secret on to the United States government. However, this year a scary thing happened for the future of our association—we budgeted a deficit, and this year it finally happened as budgeted.

I received several questions about this following the announcement in the July bundle and I hope to clear up any misconceptions. One member added all the postage of the bundles that he had received for the past 12 months and discovered that the postage was not actually higher than \$20, something I had misstated. However, this number was very close to \$20 and did not take into consideration the cost of the envelopes, and the averaging in of the costs for trial memberships, life members, and ex-presidents. The cost of mailing labels and the cost of printing the envelopes are currently a donation to the association and not reimbursed.

While trial members do not last longer than 3 months without paying dues, at any given time we seem to have several trial members. This is important to the growth of our association and something we do not wish to inhibit. When added to the life-members and ex-presidents, the individuals receiving bundles without paying dues make up about 20% of the association at this time. When the audit and



budget committees calculated the needs of the organization for mailing expenses and this was compared to annual dues income, this is where the statement that we do not cover our own mailing expenses originated.

Another important reason that we needed the dues increase would be to simply look at the National Amateur.. As the official organ of the association, it is the front face of the association. We have allotted the publication a \$5,000 budget for printing and mailing for that the past few years, and this year is no different. We put forth a beautiful publication that is worthy of being archived and kept. Yet, if you divide this amount by the membership numbers, even if we use a generous membership mailing number of 130, that is nearly \$40 per person annually for the National Amateur alone. If we take out the trial members and life members, that amount is even higher, and not including the bundle costs.

For quite some time, however, the association has not relied solely upon dues but also upon donations from members and income from trust funds. In these times of economic troubles in the United

States, the trust fund no longer contributes as much income, at a beyond the level that members can pay, because without the membership the organization is nothing. Yet, a raise up from the previous \$20 amount was clearly necessary, and the convention body voted to raise the amount to \$30.

I look forward to serving this year as President of the association and look forward to our Cincinnati/Dayton 2012 Convention. # Librarian Report

The NAPA librarian has been extraordinarily busy for the past year since the joint Illinois convention.

Funds provided by the NAPA, from 2 AAPA members and the Fossils allowed the purchase and shipment to Denver the Graham/Wesson collection of amateur journals. Several hundred hours were then devoted to the sorting of both the bound (201 bound volumes plus a rough title index) and unbound (thousands of issues) journals.

The first sub-collection organization attempted was the Lone Scout Collection coming mainly from the late Martin B. Keffer. It divides into three sections: 1916 -1931 Lone Scout papers issued by young boys; 1932-1990 papers issued by these same boys, now men recalling their youthful papers, and a partial archive of the papers from the Chief Totem and founder of the Lone Scout Fellowship Alumni until his death in the late 1990s. The American Heritage Center at the University of Wyoming (Laramie) were contacted and they have agreed to accept this portion of the collection. It will merge nicely into their previously acquired Lone Scout materials donated in the 1980s and 1990s.

Second, all amateur papers and copies of official organs for the American asso-

ciations were pulled out of the Graham/Wessen Collection. These were shipped to Vincent Golden, curator of newspapers, at the American Antiquarian Society, Worcester, Massachusetts. I then spent a total of one month as a volunteer in Worcester (November 2010 and May 2011) working with the amateur journal collection at AAS. This collection of amateur papers, possibly now numbering some 50,000 papers dated prior to December 1901 was started during the 19th century as Worcester flourished as a hub of amateur printing. Edward H. Cole then added a vast number of amateur papers (including the collection of Truman Spencer) in 1945. AAS continued to buy scattered titles for the collection as they appeared on the antiquarian newspaper market.

A separate collection at AAS will consist of the complete files of The National Amateur (1878-date), the American Amateur Journalist (1936-date) and the United Amateur for all of their factions in addition to The Fossil (1904-date). I will issue a listing of missing issues later this year. Having complete files of these official organs is the one AAS exception to having post-1902 material.

AAS asked me to first withdraw all post-1902 papers and these are being set aside with similarly dated papers from the Moitoret Family Collection. A suitable institutional repository is still being sought for these thousands of papers.

My continuing volunteer work at AAS has allowed me to bring together the existing pre-1902 collection with all papers from the Moitoret Family, my own collection formed over the past 50 years, purchased acquisitions and several thousand papers from the Graham/Wessen Collection. The best available copy is being compared and saved for the AAS collection. Each title is then being housed in a

double acid-free sleeve and envelope with the holdings printed on the exterior of the envelopes. This marks the first time in over a century that the collection will be housed in acid-free materials. These envelopes are then housed alphabetically by title.

AAS has previously placed a state-bystate listing of these titles, then arranged alphabetically by city, for those papers in the collection as of about 5 years ago. These are listed on the AAS web site.

My volunteer work will continue each six months for as long as it takes to bring the collection into a strong order. No association funds are expended in this volunteer effort save for the cost of the acid-free materials.

Third, I continue to work with Vincent Golden, AAS curator, in order to seek a few institutions for the rest of the Graham/Wessen as well as the Moitoret Family Collections. I shall also activate an advisory committee from the NAPA, AAPA and the Fossils to aid in this effort since there are vast holdings of British papers.

Fossil member Barry Schrader and I have talked about visiting the Library of Amateur Journalism at Madison, Wisconsin in order to obtain at least a spine inventory of the volumes that Edwin Hadley Smith had bound at Pratt over a century ago. I also hope to visit the Archives at the National Museum of American History, Smithsonian Institution, Washington, DC in November of this year to view the 19th century amateur papers donated to them in 1990 by the Kelsey Company as they went out of business.

I hope that my enthusiasm for all of this activity rubs off to the convention assembled. There is actually strong interest in those boy and girl printers from the Ph.D. candidates that I continue to meet as they come as fellows on grants to Worcester. Some of the finds are startling: a 6-year-old in 1860 was writing and issuing an amateur paper!

President Dave Warmer asked me to contact a dozen or so institutions currently receiving The National Amateur. Only three institutions responded that they wished to continue their free subscriptions.

My regards to the convention assembled.



# Final Report of the President July 2100

Thanks to all our members who make our organization possible. The writers, artists and publishers who grace our bundles are essential. The officers who really do the work, especially the Mailing Bureau Manager, the Official Editor and the Secretary–Treasurer make the whole thing come together. My quarterly reports have outlined the actions taken to oversee our operations for this year.

The only unscheduled blips on the screen were the need to appoint a Vice President to fill a vacancy and to take temporary custody of the Napa check book while our Secretary-Treasurer was out of commission. That was uneventful and we only had to write two checks—for the NA printing and its postage.

I have taken minimal actions beyond the required duties as president both out of disposition and necessity. Pressures of my day job expanded to a quite uncomfortable extent and diminished enthusiasm for new projects. I will have some projects to recommend to our incoming president.

While Napa is generally in good shape, the issue remains of shrinking membership. It is ever more difficult to fill elective or appointive offices. A mere handful of new young active members could turn this problem around if they are anywhere to be found.

Eventually we will need to bring dues closer in line with the costs of the association. I am uncertain how members will respond, but their dues don't even cover the postage any more. Few organizations that have regular mailing are anything like as cheap to belong to as Napa. The American Printing Historical Association has annual dues of \$65. They operate much the way we do—though they do have some expensive meetings in New York City, they are not at the expense of the association.

Laureate contests were completed in all categories with some very strong entries. The awards will be presented at the banquet.

One thing about being president of Napa is that you do get mail. Now add to that email. This is mostly spam and begging letters from college students who think we can get them a press pass to get into the Olympics for free and so on. Below is email spam we received:

## Dear Manager:

We are a Network Service Company which is the domain name registration center in Anhui, China. On February, 17th, 2011, we received HUNDI Company's application that they are registering the name "amateurpress" as their internet Trademark and "amateurpress.cn" "amateurpress asia" domain names etc., it is China and ASIA domain names. But after auditing we found the brand name has

been used by your company. As the domain name registrar in China, it is our duty to notice you, so I am sending you this Email to check. According to the principle in China, your company is the owner of the trademark, in our auditing time we can keep the domain names safe for you firstly, but our audit period is limited. If you object the third party application these domain names and need to protect the brand in China and Asia by yourself, please let the responsible officer contact us as soon as possible. Thank you.

President—Alice Brosey received 11 absentee, and 12 convention votes for a total of 23, and was confirmed as the President for 2011/2012.

Vice President—Jim Hedges received 11 absentee votes and 10 convention for a total of 21, and was declared the winner.

Official Editor—Harold Shive received 11 absentee votes and 10 convention votes for a total of 21 votes and was declared the winner.

Recorder—Marti Abell received 11 absentee and 10 convention votes for a total of 21 and was declared the winner.

Executive Judge—David Warner received 11 absentee votes and 10 convention votes for a total of 21 and was declared the winner.

The Convention site for 2012—Cincinnati received 11 absentee and 9 convention votes for a total of 20 and was declared the site for 2012. Alice reminded us that the convention site is at the discretion of the President.

Troy McQueen nominated Savannah, GA for the convention site for 2013. The vote was 10 for Savannah, 2 for Jake Warner—which always happens, and 1 for Ashtabula, OH. Savannah was declared the winner, and Troy McQueen, and Steve Powell volunteered to host.

It was moved and seconded to adjourn.

## **Convention View**

But from the moment on opening day, Thursday, July 7, when our charming and vivacious hostess Alice Brosey welcomed the 19 delegates and guests to Nashville and then presented the flag which mysteriously appeared draped over the chalkboard (stars on the left please!) to the final banging of the gavel by her efficient father, President Dave Warner, at 11:15 a.m. declaring recess until Friday morn.

# Looking Back...

The death of Charles W. (Tryout) Smith in Haverhill, Mass. on February 17, 1947 at the age of 95 brought to an end the career of the most active amateur journalist who ever lived. Born in Haverhill on October 24, 1852, he became interested in the hobby when he was twenty years old, and then only briefly as publisher of *The Boy's Companion, The Jolly Joker* and *The Nonpareil*.

In 1888, after his wife had died, he launched *The Monthly Visitor* and joined the National Amateur Press Association. He continued to publish this paper regularly for nine and a half years, skipped the last half of 1897 and all of 1898, and printed a final issue in 1899. The purchase

of a box factory made it impossible for him to go on.

He retired from business in ill health in 1903 and remained inactive until 1914, when he started his most famous and long-lived paper, The Tryout, so named because his eyes were bothering him and he wished to give them a tryout. Despite the handicap of impaired vision he published with regularity and in prodigious quantity until 1943. His poor eyesight caused him to make many typographical errors which he did not correct and which became his trade-mark throughout amateurdom. His unfailing good humor and good common sense, and his cheery works of encouragement to fledglings in the hobby increased his stature as one of the most outstanding amateurs of all time.

When Tryout was revived in 1947 he displayed his unabated enthusiasm for amateur letters by writing contributions in a shaky hand that could scarcely guide a pencil. The sturdy old heart beat strongly in a losing battle against the forces of dissolution, but the final "copy" he promised for the October 1947 number of Tryout remained unwritten. The twilight shadows deepened as 1947 drew to its close and his mind dwelt upon his early boyhood in Haverhill, of his mother putting him to sleep by candlelight in the wee trundle bed that was stored by day under his parents' bed, of the muddy streets, of the scenes of his infancy. His handwriting was rapidly becoming feebler. Then instead of letters he sent modest parcels of newsprint on which to print Tryout. Then silence.. . . And the tale is ended.


## **Hatch Print Museum**
